

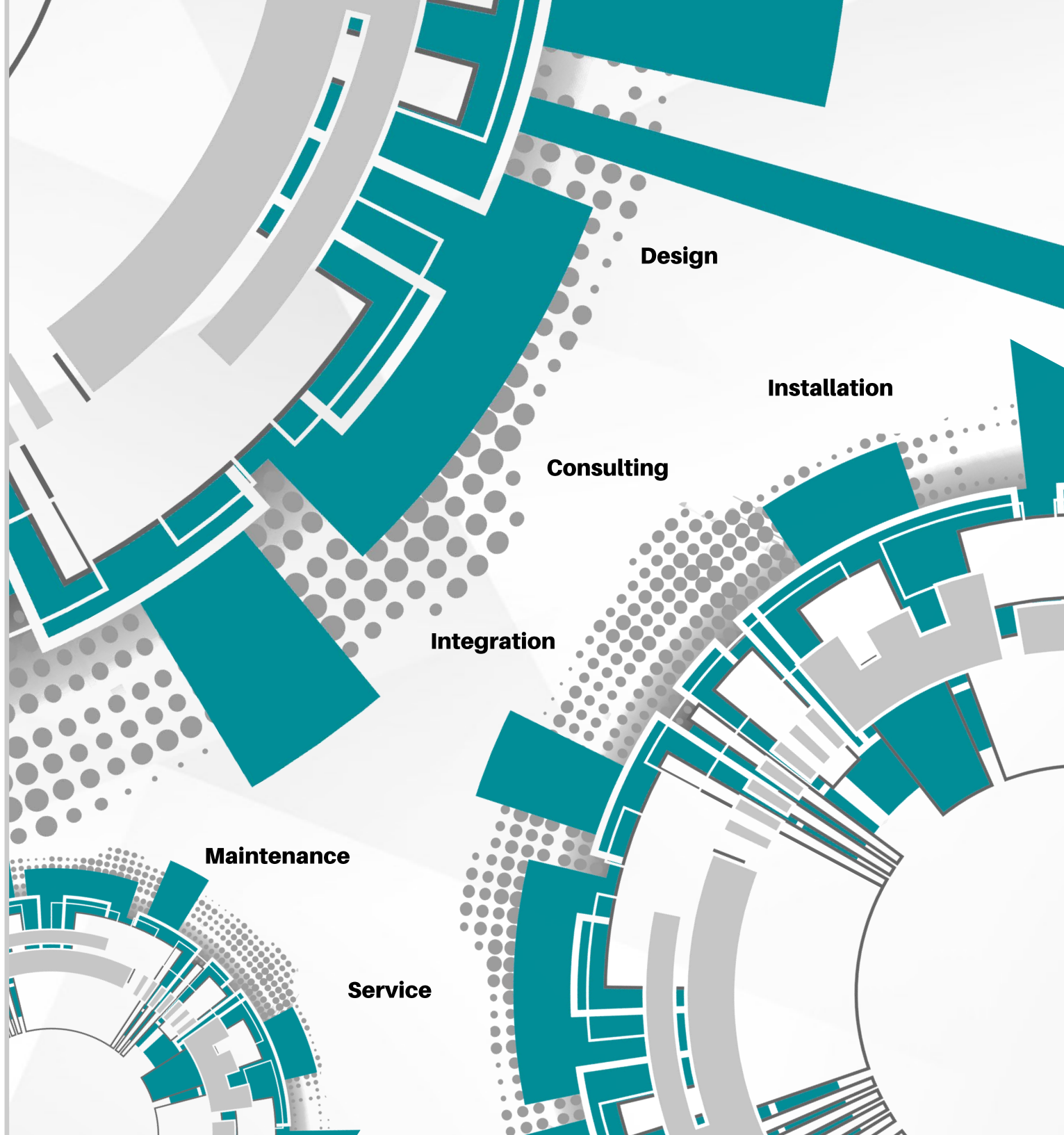

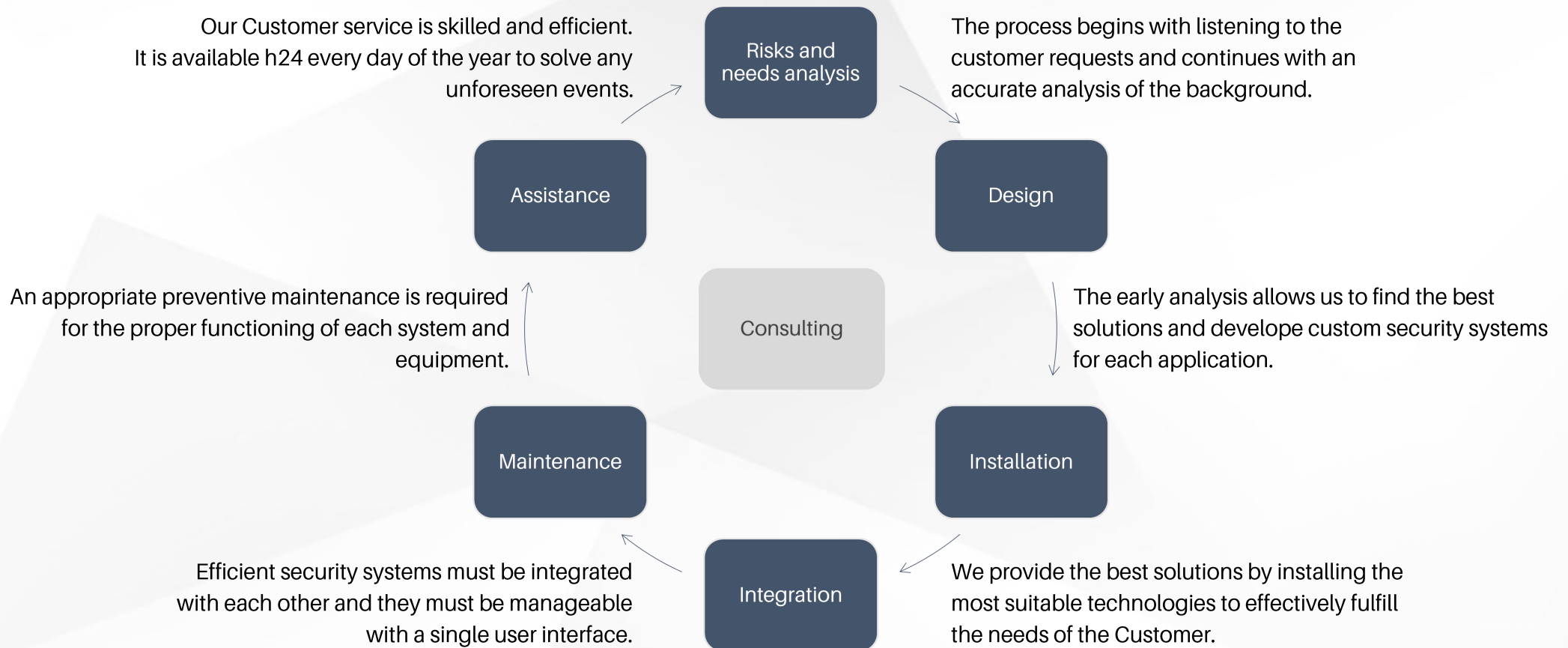
We pay special attention to the General Data Protection Regulation (GDPR n. 2016/679) and to the Statute of Workers' dispositions (art.4 L. 300/70).

# System Implementation



## DESIGN

After carefully analysing risks and needs, we design suitable solutions using CAD 2D, 3D and BIM softwares to implement the final **project**. We work in line with the reference **standards** providing the customer all the technical documentation required and bureaucratic and administrative **assistance**. We cooperate with design studios too.



## INSTALLATION

We install safety and security systems in **accordance** to the appropriate **regulations** (CEI 79-3 related to antintrusion systems, UNI 9795 to Fire Detection systems, CEI 62676-4 to video surveillance systems). We customize systems based on the characteristics of the property to be protected. After the **installation** we **test** the system according to the protocol, releasing the **DICO** as per D.M. 37/08.



## INTEGRATION

Systems work interacting with each other, ensuring the highest possible level of safety. Italsicurezza **incorporates** several safety technologies through a specific **software** to achieve this goal. The User can manage the video surveillance, antintrusion, access control, fire detection and building automation systems, through a single **interface**.

# Maintenance and intervention management

Italsicurezza offers a complete service that includes **ordinary, extraordinary and preventive maintenance** in full compliance of the standards such as the **UNI 11224** related to the fire detection systems. We improve our interventions through **softwares** always monitoring maintenances, deadlines, maintenance status, revisions, tests. The results of each intervention are recorded in the software, the technical supervisor will validate them and made them available to the Customer to be checked online/via web browser.



## PLANNING

The technical coordinator monitors deadlines and plan the maintenance interventions.



## INTERVENTION

The intervention is accomplished by qualified technicians according to the agenda.



## REGISTRATION

The outcomes of every maintenance intervention will be recorded from the technician in a tablet.

The technical supervisor validates the outcomes that are included in the software.

## VIDEO SURVEILLANCE SYSTEMS

We offer video surveillance systems for criminal acts prevention and reconstruction, process and viability monitoring through video analysis solutions.

We apply the CEI EN 62676-4 standard to our processes and we are also thermal-imaging experts.



## INTRUSION DETECTION SYSTEMS

We provide punctual, volumetric and perimeter protection solutions, and also antitheft protection by applying the EN 50131 European standard. We deal with the integration of security fogging, thermographic cameras and video surveillance to intrusion alarm systems.



## ACCESS CONTROL

We implement systems for the flows of goods and people management. We provide solutions for logistic platforms, corporate structures, office centers and parking lots. We handle all kinds of credentials (badges, multi-technology, QR codes, BLE, biometrics, license plate reading, etc.)



## FIRE DETECTION

We handle the installation, integration and the maintenance of wired and wireless fire detection systems to improve the safety of goods, building and people.

We apply the UNI 9795 standard to realize the systems, and the UNI 11224 to the systems maintenance.

# Master key systems

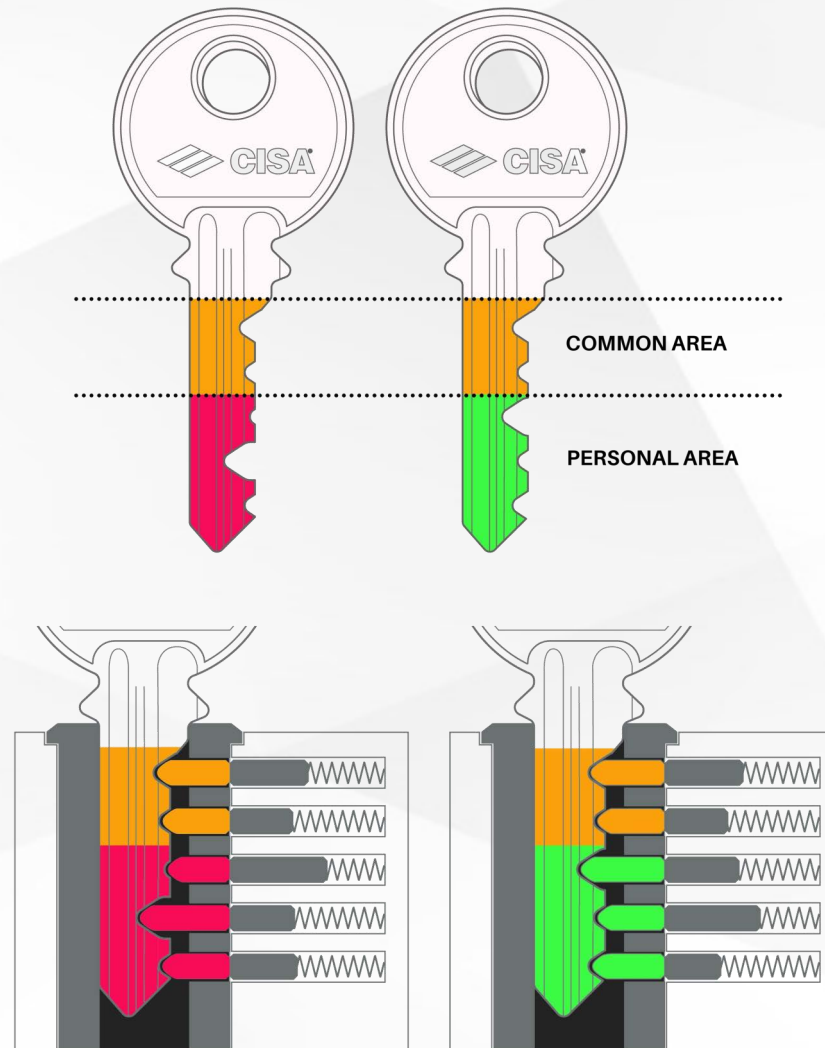
Italsicurezza is a CISA partner. CISA is one of the biggest locking and access protection systems brand by Allegion.

There are different groups of Master key systems having different security levels based on the Customers' needs:

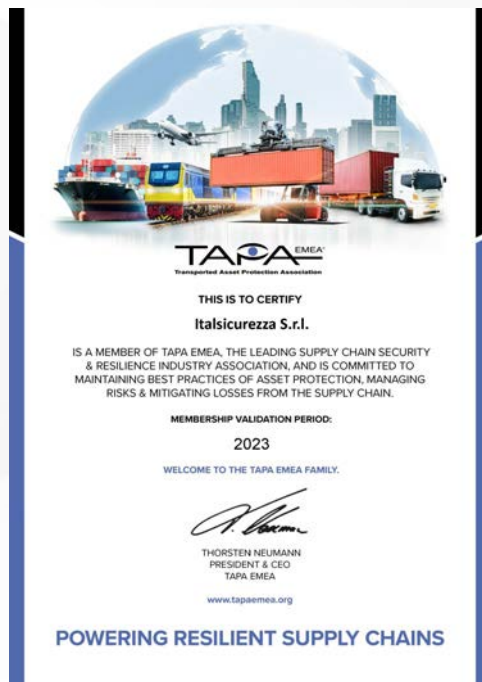
- **Single key systems:** a single key opens all the doors, allowing each member the access in every room. It is the suitable solution for individual houses

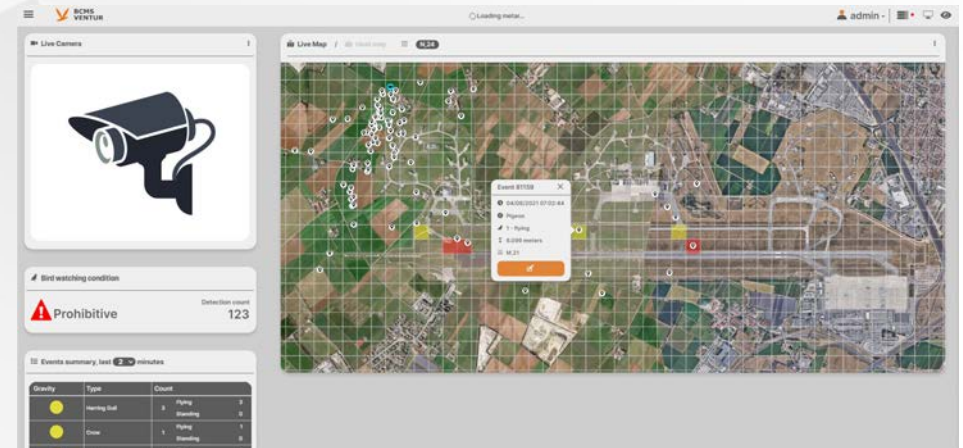
Through continuous training and periodic updating courses, we can realize advanced and high performing security systems. They take into account the activities of the criminals and the latest innovations in technology.

# Research and development projects



## Managing Physical Security e Safety through augmented reality systems

We develop an augmented reality advanced system with The Edge Company, using the Maestro system technology and Lenovo and Nvidia Hardware for the management of the preventive and repressive activity of security personnel and for fire fighting activities. The operator interacts with the PSIM (Physical Security Information Management) through Smart Glasses in the sites where a PSIM software platform is installed. He has the entire building under control thanks to the interactive graphic map and the cameras.



## BCMS Ventur: artificial intelligence against the Birdstrike phenomenon

BCMS Ventur is a revolutionary Bird and Drone Detection System developed by The Edge Company in collaboration with EVS and Verona's University. Italsicurezza gives technical support as international system integrators. The system can immediately classify birds in the airport area and identify accurately bird species, number and dimensions of the animals ensuring flights security while protecting the fauna.

## PSIM: Physical Security Information Management

PSIM systems improve safety systems effectiveness, providing the user a centralized management of individual assets. Italsicurezza mostly relies on CUBESUITE® to implement PSIM systems. It is a specific platform that allows a unified control of events and systems thanks to the contextualization of the information, thus reducing the risk of mistakes and false alarms.

The software can process several events producing reports and statistics that can be used to better the efficiency of the system.
